- Successful bidders are responsible for removal of their equipment. They are further responsible for all damages, accidents, and all other liabilities, which occur during removal, disassembly and transport.

- All bids must be received in person at 45672 Main Street, Concrete, WA 98237 or by mail at P.O. Box 39, Concrete, WA 98237 by date listed in the official bid notice by 12:00 p.m.
- All bids must be received on a copy of this form.
- Bids will be opened at 1:00 p.m. on the official bid notice date deadline and are open to all interested parties.
- Any and all bids received after 12:00 p.m. (the clock in the Concrete Town Hall will be the official time) on the ending date will be returned unopened.
- Bidder must make payment in full in cash or by check. A certified check is required for items sold for \$200.00 or more.
- Payment must be made within 5 business days of announcement of winning bid or the item will be offered to the next highest bidder.
- In the event the items are not removed from the Town of Concrete's possession within 24 hours of payment the buyer will be charged a storage fee of \$5.00 per day unless special arrangements are made in advance. Special arrangements will be granted solely at the discretion of the Town of Concrete employees or Mayor. If storage fees exceed purchase price, ownership will revert to Town of Concrete.
- In the event of 2 or more bids of the same amount for the same item/s are received, all equal bidders will be given the opportunity to place a second sealed bid of equal or greater value.
- State of Washington sales tax will be assessed on all purchases (except motor vehicles which will be paid at registration) unless a tax-exempt certificate is provided.
- All information provided is to the best of our knowledge. The bidder is responsible for the authenticity and accuracy of all information on bid items.
- The Town of Concrete is not responsible for bids that are lost or delayed in transit.
