

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist:

Governmental agencies use this checklist to help determine whether the environmental impacts of your proposal are significant. This information is also helpful to determine if available avoidance, minimization or compensatory mitigation measures will address the probable significant impacts or if an environmental impact statement will be prepared to further analyze the proposal.

Instructions for applicants:

This environmental checklist asks you to describe some basic information about your proposal. Please answer each question accurately and carefully, to the best of your knowledge. You may need to consult with an agency specialist or private consultant for some questions. You may also attach or incorporate by reference additional studies reports. The proposal is not anticipated to increase discharges to water or air, or to produce, store or release hazardous substances or to produce noise. The proposal is limited to amendments to the Town of Concrete Shoreline Master Program (SMP) addressing changes in state law, rules and changed circumstances occurring since the adoption of the SMP in 2013.

Proposed measures to avoid or reduce such increases are:

While the amendments do not propose specific mitigation measures to avoid or reduce such increases, the policies and regulations of the SMP provide guidance and a regulatory framework for specific categories of shoreline use and development. In addition the SMP incorporates by direct reference; the Town's Critical Area Regulations (CARs), adopted in 2020 which does provide specific mitigation standards.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The proposed amendments to the SMP are limited to changes in state law, rules and changed circumstances since adoption of the Town's SMP in 2013. There are no changes proposed that will affect plants animals fish or marine life beyond the existing baseline.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

No new measures to protect or conserve plants, animals, fish or marine life are proposed. It should be noted, however, that the current (2013) SMP does include policies and regulations that provide for protection of species in the shoreline environment. Similarly the SMP incorporates the Town's updated CARs which provide for specific mitigation standards for wetlands and fish and wildlife habitat areas.

3. How would the proposal be likely to deplete energy or natural resources?

The proposed amendments would not be likely to deplete energy or natural resources.

Proposed measures to protect or conserve energy and natural resources are:

The intent of the SMP is, in part, to conserve energy and natural resources. Similarly the recently amended CARs incorporated by reference in the SMP focus on the conservation of wetlands, fish and wildlife conservation areas, frequently flooded areas and geological hazard areas.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

The proposed amendments would not be likely to affect these areas or resources as they are largely limited in scope to state laws and rules adopted since 2013. The intent of the current SMP is, in part, to conserve such areas and resources.

Proposed measures to protect such resources or to avoid or reduce impacts are:

The current SMP provides policies and regulations that address protection of such areas and resources.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The proposed amendments do not include substantive changes to the policies and shoreline use regulations included in the current SMP.

Proposed measures to avoid or reduce shoreline and land use impacts are:

There are no new measures proposed to reduce shoreline and land use impacts.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

The proposed amendments will not increase demands on transportation, public services and utilities over the existing baseline condition or level of service.

The existing SMP addresses transportation and utilities including existing Puget Sound Energy hydroelectric generation facilities at the Lower Baker Project site.
